Training course and examination for BMX International Commissaires

Dear Madam, Dear Sir,

We would like to inform you that the UCI is organising a course and examination session for candidates who wish to become UCI International BMX Commissaire.

The course details are as follows:

Venue: Aigle - Switzerland (World Cycling Center)

Dates: 3 days between October and November 2010 (dates to be confirmed)

Maximum number of participants: 20

Language: English

We take the opportunity to remind you of the article 1.1.054 of the UCI rules:

To be able to be admitted to the selection procedure to become UCI international commissaire, the concerned person has to meet the following conditions:

- 1) be a member or licence holder of a UCI-affiliated national federation;*
- 2) be proposed by that national federation. This federation shall be required to submit an application signed by its president or a person delegated by its president which shall include the following documentation:*
 - a copy of an official identity document (passport, etc.) showing that the candidate is aged between 25 and 50 years in the year of his selection by the UCI;*
 - evidence of his having followed and passed a training course for national commissaries given by a person approved by the UCI;*
 - ~~*- evidence that he has served actively as a national commissaire in the two years preceding the selection;*~~
- 3) have an excellent knowledge of the UCI regulations;*
- 4) have a command of the official course language, which will be one of the two official UCI languages(French or English).*

The UCI operates a first selection, based on the files received and the places available. The candidates selected must pass the preselection examination, in which the knowledge of the UCI regulations and the language of the course shall be tested.

In case of failure, the candidate shall be permitted to resit for the preselection examination only once.

Complete applications must be submitted (indicating priority order for selection) to the UCI via the National Federations. The choice of candidates is yours, bearing in mind that UCI looks for candidates with good experience in refereeing national events, and who fulfil the above mentioned conditions (article 1.1.054 of the UCI rules).

For each candidate, we ask you to enclose a copy of his/her official identity document as well as a **certificate or diploma** of bmx national commissaire. **Without these documents, the file will not be considered.**

Applications must arrive at the latest on **19 March 2010** to the following address:

The selection of the participants to the pre-selection exam will be made by the Commissaires Unit and will be communicated to the concerned parties by **2nd April 2010**. The UCI reserves the right to choose the candidates with the highest potential to become BMX international commissaires and to consider the current needs of international commissaires in countries and continents. The dates and venue of the preselection exams will be communicated to you at a future date.

The costs of travel, accommodation and food must be paid in full by the participants. However, the UCI will offer them the most favourable arrangement.
