
1. STUDY

3. DELEGATE

disciplines specific instructions internally within your National Federation and make sure that the person in charge of the discipline in question is aware of this Registration Procedure.

within the imposed deadlines, all the approved registration forms to the UCI Sport and Technical Department.




7. CONTROL

the registration of your events in the calendars published on the UCI website once they have been approved by the UCI Management Committee.

GENERALITIES CONCERNS ALL THE DISCIPLINES

N. B.: The purpose of this document is to ease the entire registration procedure for events on the UCI international calendars, in a standardized way from one discipline to the other.Regulations are here explained but not dealt with in a detailed, exhaustive manner. Please refer to the UCI Regulations in all cases as these rules prevail

THE REGISTRATION PROCEDURE FOR UCI CALENDARS

TO WHOM IT MAY CONCERN?

This document is intended to help National Federations, Organisers and Continental Confederations with the registration of next season's events on the international calendars, for all disciplines:

WHAT IS THE PURPOSE?

In respect to **Articles 1.2.001 and the articles that follow** of the UCI Regulations, each year, Organisers shall apply to their respective National Federations to have their races included on the world or continental calendar. **(Article 1.2.006)** With the exception of UCI WorldTour events, the world and continental calendars are determined by the UCI management committee on the advice of the Continental Confederations for the competitions which concern them. **(Article 1.2.005)**

In order to be able to be registered on the UCI international Road calendar, a race must guarantee the participation of **at least 5 foreign teams**. A mixed team is regarded as a foreign team if the majority of its riders are of foreign nationality. (**Article 2.1.003**)

The Organiser of Cyclo-cross, Mountain Bike or BMX event on a national calendar in which riders of **three or more foreign federations** participated, **two foreign federations** for a Track, Trials or an Indoor cycling event, must request the inclusion of the next edition of his event on the international calendar. The event shall not be included in the national calendar, except if its inclusion in the international calendar is rejected.


The Organiser of Paracycling event on a national calendar in which riders of many foreign federations participated, **as per Article 16.18.003**, must request the inclusion of the next edition of his event on the international calendar. Organisers of C1 events have to **guarantee the minimum number of nations** as per **Article 16.18.003**, otherwise downgraded as C2 events the year after.

Regarding Road, National Federations shall pass on applications for inclusion to the UCI with a copy to their Continental Confederation **no later than June 1**st of the year preceding that for which inclusion is required. For Indoor cycling, Para-cycling and Cycling for all, the deadline shall be set at July 1st. For MTB, BMX and Trials, this date is the **last Friday of July** as for Track and Cyclo-cross, the deadline shall be set at **December 15th**.

The application of the National Federations must be filed according to the instructions given by the UCl administration and confirms in any case the Organiser's commitment to submit to the UCl constitution and regulations.

If a race is run over the territory of several countries, the race shall be included on the calendar only with the agreement of the federation of each country concerned. (Article 1.2.006)

HOW DOES IT WORK?



1

In April each year, an email is sent to National Federation and Continental Confederations in which they may find an hyperlink to this document which is available for download.

An email is also sent to Organisers that held events the previous year. In this email, there is a hyperlink to this document which is to be downloaded together with a pre-filled event specific registration form in attachment.

2

Organisers that held events the previous year must check, complete and approve the pre-filled form for each of their event(s) and send it by e-mail to their National Federation in order to confirm the registration.

In case of a new Organiser, they must contact the National Federation of the country/-ies in which the race takes place.

3

No later than by 1st June, respectively 1st July (Indoor cycling, Paracycling and Cycling for all), the last Friday of July (MTB, BMX, Trials) or December 15th (Track and Cyclo-cross), the National Federations send every completed and approved registration form to the UCl by e-mail Information about this procedure is detailed in the next section of this document.

Registration forms directly sent by an Organiser to the UCI, without going through the National Federation, are not accepted. Only National Federations are entitled to process registration forms.

The Commission of the discipline in question and/or the working group in question consider/s registration requests and builds calendar for the upcoming season.

5

Then, the calendar for next year will be presented to the UCI Management Committee for approval.

Once approved, the calendar will be published on our website the next working day following the UCI Management Committee meeting. In order to simplify the procedure, an individual answer will not be sent to each National Federation or Organiser, but you will be informed of the decisions of the UCI Management Committee by consulting the calendar published on the UCI website.

HOW TO FILL IN THE REGISTRATION FORM?

THE ORGANISER

EXISTING EVENTS

The Organiser receives for each of their events a pre-filled form by PDF file with specific information about the event as it appears on the draft calendar (available hereunder in this document, in the disciplines in question). The Organiser can make any necessary changes directly in the pre-filled PDF file. Then it must be sent by email to the National Federation for approval.

NAME

In the event of any name change, the Organiser must mention the name requested in the box provided.

DATES

The **draft calendars** are included hereunder in this document for informational purposes. Appearing on a draft calendar does not mean that the race is registered on the UCI calendar. Organisers must confirm the **registration of their race** by sending back the required registration form to their National Federation.

Any requests for a change of date may be submitted to the UCI **via National Federations.** A **justification letter** must go along with these requests.

If necessary, the UCI reserves the right to **change the dates** in order to avoid any situation where there may be competition between races which may be unfavourable to cycling.

NEW EVENTS

For registration of new events, extra forms can be obtained from the National Federation. Hyperlinks to blank specific registration forms for each of the disciplines can be found hereafter in the corresponding parts. In accordance with the regulations, when registering a new race a file must be submitted (Article 1.2.009 hereafter). For the Road, this must reach the UCl at the latest on 25th June (3 months prior to the Management Committee meeting) of the year before the first edition of the race, or at the latest on the same registration deadline settled in Article 1.2.006 for the other disciplines. Nonetheless, the Organiser is obliged to announce beforehand its intention to enter a new race to its National Federation who will send the Organizer a blank registration form to fill in and send it back to their National Federation.

1.2.009

The first time a race is submitted for inclusion on the international calendar, the Organiser shall submit documentation including at least the following information:

- type of race (discipline, speciality, format);
- description of the course including total length (in km) and, where applicable, that of stages and circuits;
- the type and number of participating teams and/or riders' categories wanted;
- financial aspects (prizes, travel and subsistence expenses);
- references concerning organisation.

For the Road, the documentation must be submitted to the UCI no later than three months before the meeting of the management committee at which the calendar in question is finalised, or at the latest on the same registration deadline settled in **Article 1.2.006** for the other disciplines.

GENERALITIES CONCERNS ALL THE DISCIPLINES

VALIDATION

By filing its application, the Organiser commits to respecting the UCI constitution and regulations. (Article 1.2.006) The Organiser attests to the information on the form by writing his name and the date of the day at the left bottom of the form.

We remind you that any registration must be approved by the National Federation which will send the information by e-mail to the UCI no later than by the 1st of June of the year in question for Road, or by the dates settled in **Article 1.2.006** for the other disciplines.

We ask you to use the **electronic registration** form only to register your event.

Registration requests which are **not in compliance** with the above-mentioned requirements, will be sent back to the National Federation concerned.

We draw your attention to the fact that according to the **Article 1.2.012** of the UCI rules one of the requirements to enter an event on the International Calendar is the payment of the invoices concerning the previous year events (calendar fee) and any other financial obligation with the UCI.

DEADLINE

The deadline for sending back registration forms to your National Federation by e-mail is at the latest 2 weeks before the deadlines settled in Article 1.2.006 of the Regulations, which deadlines are:

June 1st: ROAD

July 1st: INDOOR CYCLING, PARA-CYCLING, CYCLING FOR ALL

Last Friday of July: MTB, BMX, TRIALS December 15th: TRACK, CYCLO-CROSS

In order that we can submit the international calendar to the UCI Management Committee, we ask you to respect the deadline to send the registration forms.



THE NATIONAL FEDERATION

EXISTING EVENTS

The Organizers of events mentioned on the UCI draft calendar have received a pre-filled PDF file completed with specific information of their event(s). The Organizers have been asked to fill in and return the PDF file electronically to you no later than 2 weeks before the dates settled in Article 1.2.006 of the regulations in order that you can send on time to the UCI all the registration forms of the events that you want to register, in one e-mail: sport.technical@uci.ch

NEW EVENTS

The National Federation has access to blank forms to be sent to the Organiser who announces its intention to enter a new race in the UCI international calendar. **One will find hyperlinks to the blank forms for each discipline in the specific parts later on in this document.**

In accordance with the regulations, when registering a new race **a file must be submitted (Article 1.2.009 hereafter)**. For the Road, this must reach the UCI at the latest on **25**th **June** (3 months prior to the Management Committee meeting) of the year before the first edition of the race, or at the latest on **the same registration deadline** settled in **Article 1.2.006** for the other disciplines.

VALIDATION

The National Federation checks the amended PDF file, **approves it electronically** directly in the PDF file in the box "Approval of the National Federation" and returns it to the UCI, by e-mail sport.technical@uci.ch

DEADLINE

The National Federation requests the registration of the events through the registration forms received from Organizers. All the forms must be sent **in one email** addressed to the UCI Sport and Technical Department (sport.technical@uci.ch) within the deadlines stated in **Article 1.2.006**:

June 1st: ROAD

July 1st: INDOOR CYCLING, PARA-CYCLING, CYCLING FOR ALL

Last Friday of July: MTB, BMX, TRIALS December 15th: TRACK, CYCLO-CROSS



WHAT ARE THE COSTS?

FINANCIAL OBLIGATIONS

The UCI establishes, for each calendar and each class of race, a range of calendar fees as well as participation allowances and prize money. These amounts are described in the UCI Financial Obligations.

One will find **hyperlinks** to the Financial Obligations for each discipline in the specific parts later on in this document.

ECONOMIC CLASSIFICATION

The amounts of calendar fees and prizes will be adapted based on the economic situation of the country. Therefore, reference should always be made to the coefficients of the Economic Classification of the countries:

RIGHT TO REGISTER

The registration fee of every event is subdivided into 3 parts:

1. UCI CALENDAR FEE

In compliance with **Article1.2.012**, the inclusion of a race on the international calendar shall be subject to the payment of a fee, called the calendar fee, the amount of which shall be set annually by the UCI management committee.

This fee includes allowances (expenses and travel) for officials (International Commissaires and Doping Control Officers) appointed by the UCI and enrolment fee for each race on the international calendar. The accommodation expenses (room + breakfast) remain payable by each Organiser. The total amount of these fees must be paid in Euros, within the term described in the **Article 1.2.012.**

PAYMENT:

- → An invoice will be sent to Organisers once the calendar is approved by the UCI Management Committee
- → The total amount of the fee must be paid by the Organiser to the UCI no later than two months after the meeting of the management committee at which the calendar for the discipline in question is approved. The above deadline is the date on which the UCI account must be credited. (Article 1.2.012)
- → Only races having respected Article 1.2.012 of the UCI regulations will be registered on the calendar.
- → In case of delay, a penalty of 100 Swiss francs for each month started will automatically be applied. (Article 1.2.012)
- 2. ANNUAL CONTRIBUTION TO THE CYCLING ANTI-DOPING FOUNDATION (CADF))
 - → ORGANISERS
- 3. ANNUAL CONTRIBUTION TO THE CYCLING ANTI-DOPING FOUNDATION (CADF)
 - → RIDERS

REGISTRATION REFUSAL

The inclusion of the race on the following calendar shall be refused should the fee of the previous year, as well as the penalty not have been paid one month before the meeting of the management committee at which the calendar in question is approved. Furthermore, a race inscription shall be refused if the enrolment fees for previous races have not been paid or if the Organiser does not honour its financial obligations with the UCI. This measure also applies to the new Organiser of the race and, in general, to the Organiser and/or race that the management committee considers to be the successor of another Organiser or another race. (Article 1.2.012)

INVITATION - ENROLMENT

In accordance with **Article 1.2.048**, without prejudice to the provision concerning Mountain Bike, BMX, Indoor cycling, le Paracyclisme, Cycling for all and the Maters category, Organisers of events registered on the international calendar are not allowed to demand from riders and/or teams any participation fee whatsoever (contribution to expenses, registration fees, etc).

OTHER ITEMS

NATIONAL CHAMPIONSHIPS

As stated in **Article 1.2.029**, National Road Championships shall be run during the **last week of the month of June, so from 23 to 29 June 2014. If this is not the case, no UCI points may be awarded.**

- → The National Cyclo-cross Championships shall be run on the date approved by the Management Committee.
- → National Mountain Bike Championships shall be run on the 29th weekend of the year.
- → National BMX Championships shall be run on the first weekend of July
- → National Trials Championships shall be run on the last weekend of June or on the National Mountain Bike Championships mandatory weekend when National Trials Championships are organized together with the National Mountain Bike Championships.
- → National Indoor cycling Championships should take place in principle 4 weeks before the World Championships.

The UCI may grant dispensations for the southern hemisphere or in cases of force majeure. It is highly advised not to register any race for those periods. One might find **hyperlinks to the registration forms** for the National Championships for each discipline in the specific parts later on in this document. **The National Championships are published in separate calendars.**

GENERALITIES CONCERNS ALL THE DISCIPLINES

CONTINENTAL CHAMPIONSHIPS

The Continental Confederations must send this the registration form to the Organizer chosen for the organisation of the Continental Championships. The organizer must return this form to the Continental Confederation duly filled in and signed. The Confederation approves the information by signing the form and sends it to the UCI Sport and Technical Department no later than by June 1st, for all the sports disciplines. One might find hyperlinks to the registration forms for the Continental Championships for each discipline in the specific parts later on in this document.

DATE CHANGES

Any change to the date of an event included on the international calendar shall be subject to prior authorisation by the UCI or, for a UCI WorldTour event, the Professional Cycling Council at the request of the National Federation of the Organiser. If there is a change of date or if an event is cancelled, the Organiser shall be liable for a fine the amount of which shall be set each year by the management committee. (Article 1.2.014)

CLASSIFICATIONS AND CUPS

Please note that, according to **Article 1.2.026**, National federations, their affiliates and licence holders and, in general, all bodies answerable to them shall be barred from participating actively or passively in any individual or team classification based on the races on the international calendar other than those drawn up or expressly authorised by the UCI. Events conducted by an organiser who fails to comply with the preceding paragraph shall be deleted from the international calendar for the following year. In any case, for Mountain Bike and Cyclo-cross, a "Cup/Series" will be comprised of no more than eight rounds.

FORBIDDEN RACES

In order to remind you: No licence holder may participate in an event that has not been included on a national, continental or world calendar or that has not been recognised by a national federation, a continental confederation or the UCI.

A national federation may grant special exceptions for races or particular events run in its own country. (Article 1.2.019)

CLASSIFICATION

The UCI Management Committee and Road Commission reserve the right to change the classification of races at the meeting of the Management Committee which will be held in September, based on the level of participation and the quality of the organisation of races. For races registered in October through to January, the forms will be examined by the Management Committee in June, when it will, or not, give its approval with the aim of anticipating the appointments of the commissaires. The Organiser will be informed of this. However, the calendar will remain as usual, with final approval given at the Management Committee session taking place in September.

HOW MUCH DOES IT COST FOR ROAD?

FINANCIAL OBLIGATIONS

Please find a hyperlink to the Road Financial Obligations for next year with the amounts regarding calendar fees, participation allowances and prize money.

For the events of the UCI WorldTour calendar and the races of the UCI Continental Circuits "Men Elite", classes HC and 1, the contribution of athletes to the Solidarity Fund for Professional Riders, is 7% of the total of prizes actually distributed. This amount will be billed to the paying body (e.g. National Federation, Organiser, riders' association, etc) by the CPA..

REGISTRATION FORMS ROAD

Each form must include only **one race**, even if several races that are open to different categories take place on the same day at the same venue.

MAIN ORGANISERS' OBLIGATIONS

1. SENDING BID FILE BY 17 MAY 2013

The **new candidates** who wish to obtain the 2014 World Cup label, must submit a candidature file to the UCI Sport and Technical Department through the National Federation. The following points must be mentioned in the bide file:

- → Full contact details of the Organizer
- → References of the Organizer
- → Technical guide and media report of the previous edition
- → Dates requested
- → Race schedule
- → Access to the venue (airport, highway network, etc...)
- → Circuit
 - Map, profile, distance, length of the circuit, description of roads used, according to the UCI rules.
 - A race lasting 3 hours/3 hours and half is considered appropriate (between 120 and 140Kms according to the **Article 2.3.002** of UCI rules)
- → Detailed map showing the start and finish areas
- → Installations available
- → Media Plan and project of the TV coverage
- → Accommodation
- → Provisional budget
- → Motives of the bidding

This application request for the organization of a World Cup round must be received at the UCI no later than 17th May 2013. Only complete files which reach the UCI within the stipulated deadline will be taken into consideration.

This applies only for the new candidates. Organizers having already obtained the label in 2013 are not required to send a candidature file.

2. BID EXPENSES FOR THE NEW REQUESTS

We remind you that the new candidates who will submit a file for a World Cup shall pay a candidature fee of EUR 1'000.- . This amount shall in particular cover the costs of the visits made by UCI representatives as well as the costs of evaluating and processing the bid. If the bid is postponed to another year, the costs shall not be paid again. They shall be retained in the event that the bid is rejected. The Organising Committee must cover accommodation and subsistence expenses of the UCI representative during the visit.

Only the files whose bid expenses are paid to the UCI will be considered. Upon payment, indicate the name of the race and World Cup.

When making its choice, the UCI will take into consideration other stage races on the UCI calendar which will be held near the time in the same region, with the aim of reducing the expenses for teams. Nevertheless, there must be at least one day between the UCI World Cup race and the above-mentioned races.

ORGANISERS' RIGHTS

All marketing and sponsorship rights for the title and format of the UCI World Cup are the exclusive property of the UCI. The UCI grants the Organizer the marketing and sponsorship rights for its race, apart from the rights for the "presenting sponsor" for the UCI World Cup series, which remain the property of the UCI.

The Organizer must use the UCI World Cup label according to the UCI visual identity guidelines.

The UCI grants the event Organizer the exclusive standard television rights, except:

- → for the right to distribute a 3 minute edited news item.
- → for the right to edit and distribute international highlights packages of 30 minutes.

The rights for the 3 min news items and the 30 min highlight package shall be non-exclusive for the the UCI and the Organizer in order to generate an exposure for the events as wide ranged as possible.

All rights for broadcasts on all other forms of modern linear and non-linear communication, including but not limited to internet, mobile communication devices etc. are the exclusive property of the UCI who will do its best efforts to promote the UCI Women's Road World Cup with the help of these media.

On request UCI may grant a broadcaster or website of the country where the event takes place the non-exclusive right to show the event on its website live or on demand (VOD) with geo-blocking technology for internet users outside the hosting country.

TV (UCI WOMEN'S ROAD WORLD CUP)

1. TV PRODUCTION AND FOOTAGE REQUIREMENTS

The Organizer must guarantee that a TV channel / TV Production Company with sufficient experience and the necessary equipment will produce the race according to the UCI standards below.

The Organizer has to provide a detailed production plan and contacts of the responsible producer to the UCI three months before the event at the latest. The UCI retains the right to refuse this plan and demand changes in order to ensure consistent high production qualities across all events.

UCI WOMEN'S BOAD WORLD CUP

The Organizer undertakes to provide a **three minute edited** news item to the EBU news distribution system EVS.

This footage has to fulfil the minimum requirements of the UCI hereafter:

- → Minimum content: Start of the race, one or the other decisive race action, finish with arrival of the winner and podium presentations.
- → International sound
- → Delivery to EBU / EVS news distribution service by satellite or fibre free of charge
- → Playout not later than 2,5 hours after the finish of the race
- → In case the playout is from overseas it has to be coordinated with the EBU to be in time for a playout early the next day
- → A dope sheet / shot list must be sent by e-mail, UCl will provide a template before the start of the event series.
- → Via FTP the news file has got to be transferred to the UCI respectively by one of his partners at the latest on the next work day

As part of the **UCI's women in cycling project** UCI has a dedicated TV crew as well on site for delivering dedicated interviews which will be used for a news item on www.youtube.com/ucichannel and for the 26-min highlight programs:

- → The news edit for EVS by your Host broadcaster needs to be available for the UCI TV crew on site in a digital format and not on tape.
- > The UCI TV crew must receive accreditation as a rights holder.
- → For the UCI TV crew a DSL high speed internet line for an upload of a video file must be made available.

The Organizer undertakes to deliver a **60min 'rough cut'** of the event to the UCI two days after the event at the latest. Please note the following points in order to provide the right material to our editing partners.

The footage of your race shall be a rough cut of app. 60 min showing:

- → Inscription of the riders
- → Beauty shots / Scenic shots about the area / region.
- → Start of the race (depart fictive and depart real)
- → Riding with important attacks and other important incidents escapes, crashes etc.
- → Winner crossing and other groups crossing the line
- → Podium with 1 -3 and all jersey presentations
- → Winner interview with neutral Microphone.

INTERNATIONAL SPECIFIC INSTRUCTIONS

FOR CALENDAR TRACK

CLASSIFICATION

The class of the event determines the points awarded to the participants as per the scale stated in the UCI regulations (Title 3, Chapter III).

The events registered in the 2013-2014 calendar will be evaluated on the basis of the quality of the participation and organisation in order to determine the class in which they will be registered for the 2014-2015 season.

Any event for which points counting for the UCI Track Individual Classification are awarded will need to respect the formats and/or minimal distances as stipulated in the UCI Regulations, failing which points will not be awarded.

For your information, please find hereafter three examples to illustrate how criteria are taken into account to classify an event:



CLASSE 1 EVENT

According to Article 3.8.003 of the UCI regulations, such class event must fulfil the following criteria:

■ 5 PARTICIPATING NATIONS

The number of nations considered is the event among the programme in which the maximum of nations are represented. In terms of points granted to riders, any events in the programme where at least 5 nations are competing, riders will be awarded points according to the scale provided for a class 1 event.

If some events in the programme have only 4 nations at the start, riders will be awarded points according to the scale provided for a class 2 event.

If other events in the programme have only 3 nations at the start, riders will be awarded points according to the scale provided for a class 3 event.

Finally, if some events in the programme have between 1 to 2 nations at the start, no points will be awarded to riders competing.

■ EVENTS FOR MEN ELITE

plus 3 other categories to be chosen from Women Elite, Men or Women U23, Men or Women Junior.

The requirement of events for 4 categories to be organised within the competition's programme take into account all events organised, even those with one country represented at the start.

■ 5 COMPETITIONS MINIMUM

(event part of the World Championships programme in one category).

The requirement of competitions take into account any event's type represented at the World Championships, regardless of the number of nations at the start of those events.

MEN ELITE	Points race (8 nations at the start) → eligible for class 1 points
Women Elite	Sprint (3 nations at the start) → eligible for class 3 points
WOMEN JUNIOR	Scratch (2 nations at the start) → not eligible for points
MEN U23	Madison (4 nations at the start) → eligible for class 2 points
MEN ELITE	Scratch (5 nations at the start) → eligible for class 1 points

CLASSE 2 EVENT

According to Article 3.8.003 of the UCI regulations, such class event must fulfil the following criteria:

■ 4 PARTICIPATING NATIONS

The number of nations considered is the event among the programme in which the maximum of nations are represented. In terms of points granted to riders, any events in the programme where at least 4 nations are competing, riders will be awarded points according to the scale provided for a class 2 event.

If some events in the programme have only 3 nations at the start, riders will be awarded points according to the scale provided for a class 3 event.

Finally, if some events in the programme have between 1 to 2 nations at the start, no points will be awarded to riders competing.

■ EVENTS FOR MEN ELITE

plus 2 other categories to be chosen from Men or Women U23, Men or Women Juniors. The requirement of events for 3 categories to be organised within the competition's programme take into account all events organised, even those with one country represented at the start.

■ 3 COMPETITIONS MINIMUM

(event part of the World Championships programme in one category).

CLASSE 3 EVENT

According to Article 3.8.003 of the UCI regulations, such class event must fulfil the following criteria:

■ 3 PARTICIPATING NATIONS

The number of nations considered is the event among the programme in which the maximum of nations are represented.

In terms of points granted to riders, any events in the programme where at least 3 nations are competing, riders will be awarded points according to the scale provided for a class 3 event.

If some events in the programme have between 1 to 2 nations at the start, no points will be awarded to riders competing

■ EVENTS FOR MEN ELITE

plus 1 other category to be chosen from Men or Women U23, Men or Women Juniors. The requirement of events for 2 categories to be organised within the competition's programme take into account all events organised, even those with one country represented at the start.

■ 2 COMPETITIONS MINIMUM

(event part of the World Championships programme in one category).

The requirement of competitions take into account any event's type represented at the World Championships, regardless of the number of nations at the start of those events.

Example of possible minimum programme for a class 3 event

MEN ELITE Keirin (4 nations at the start)

> → eligible for class 3 points (even with 4 nations represented, the registered class of the event determines the maximum applicable points scale).

WOMEN ELITE Sprint (2 nations at the start)

→ not eligible for points

With 2 categories, a maximum of 4 nations in one event and 2 competitions, such event would be classified in class 3.

An additional event such as a Points race for Men U23, even with only one nation represented at the start, would enable that event to be promoted in class 2.



FORMAT OF THE EVENT:

- → Cross-country stage race: XCS
- → Cross-country marathon: XCM (UCI MTB Marathon Series)
- I → ndividual downhill: DHI
 - → Four Cross: 4X



UCI PARA-CYCLING ROAD WORLD CUP

BIDDING

1. BID FILE INTRODUCTIONE

The International Cycling Union (UCI) has made this document in order to facilitate the management and the organization of the UCI Para-cycling Road World Cup, to spare time and efforts and also so that the concerned collaborators for the preparation of a candidature relating to the organization of a Para-cycling Road World Cup leg can find the most information in one file.

Any introductory notes that are appropriate as well as any other supporting letters and documentation from public / tourism / city authorities should be supplied.

A letter of introduction on a letterhead from the Host National Cycling Federation is compulsory.

2. CHOICE OF DATE & EVENT

The UCI Para-cycling Road World Cup comprises a maximum of 4 rounds, organized on the following possible dates, fixed in advance by the UCI, protected in the International UCI Calendar, subject to changes and already partly granted.

Date	Discipline
18 th or 19 th week of the year	UCI World Cup Asia-Oceania-Africa
21 st or 22 th week of the year	UCI World Cup Europe
23 th or 24 th week of the year	UCI World Cup Europe
27 th or 28 th week of the year or the week before the Road World Championships	UCI World Cup Nord American

When making its choice, the UCI will take into consideration, besides the technical qualities of the bids, the geographical distribution and location, with the aim of reducing the travel expenses for riders.



3. ORGANISATION FEE

The amount of 9'000 must be paid to the UCI for the organisation rights of a UCI Para-cycling Road World Cup round. The expenses are fixed at 75€ maximum by accredited inscription (athlete and staff team). The UCI will charge an amount of 10€ for each accredited person.

4. MARKETING RIGHTS

The UCI is the sole and exclusive owner of all marketing rights in and to the UCI Para-cycling Road World Cup. Nevertheless, the UCI grants the Organizer an average of 80% of the marketing rights, depending on location (*see enclosure 1*). The UCI reserves 20% of the marketing rights for the UCI sponsors.

■ UCI SPONSORS AND PRODUCT CATEGORIES

The Title and presenting sponsors rights for the UCI Para-cycling World Cup will be exclusively reserved for UCI sponsors. Furthermore, the UCI can also bring in other sponsors for this World Cup. All UCI sponsors for the UCI Para-cycling World Cup will be granted the exclusivity in their product category. The UCI will confirm as soon as possible any new sponsors (Title, Presenting and other Sponsors). The UCI reserves the following product categories exclusively for the UCI sponsors:

- Transport and Logistics Management
- Cycling clothes
- → The Organizer is free to negotiate with sponsors in other product categories, provided that the exclusive rights of the UCI Sponsors are scrupulously protected.
- → The Organizer agrees not to enter into any partnership with any tobacco manufacturer, companies producing pornographic products or companies of sport bet.

■ SPONSORS HIERARCHY

There is a clear sponsors/commercial partner hierarchy which will exist for the event:

- Title sponsor = TBC (UCI)
- Presenting Sponsor = TBC (UCI)
- The host venue. It is defined as follow: the town, region, resort or tourism are reserved exclusively for the Organizer
- Any other Local Organizing Committee sponsors and UCI sponsors
 This hierarchy must be observed in every aspect of the event.

5. UCI POINTS

The UCI World Cup events are highly granted with UCI points (*enclosure 2*) for the UCI Para-cycling ranking.

6. TELEVISION

In the event a TV production will be done, this will also be made available to the UCI which may use these images on a non-exclusive base. For avoidance of doubt, this does include Internet, DVD, 2 and 3 G, Telecom, Giant Screen, and any and all multimedia rights) in and to the World Cup and the Competition.

It is not mandatory to offer TV Coverage during the Para-cycling Road World Cup rounds, although it will give more points in the evaluation of a candidacy if an Organizer can provide some kind of interesting coverage.

7. RESPONSIBILITIES OF THE UCI

- UCI Para-cycling Road World Cup Label;
- · General coordination of the Series;



- · General press service, including Internet service (results and resume on the UCI Website):
- Practical Organisation Guide;
- One timing supervisor/expert for each round;
- · Visual Guidelines (start & finish infrastructure details, backdrop for the podium, dimensions for the poster, etc.);
- · Appointment and payment of a technical delegate, an two (2) UCI international commissaires, an tree (3) UCI international classifiers and doping control officer (daily allowances & travel expenses);
- · Online registration;
- Attribution of the leader jersey, on the provisional general classification of the World cup after each round and of the trophy on the final general classification. This in each sporting class, men and women (individual);
- Implementation of the UCI sponsors.

8. RESPONSIBILITIES OF THE OC

- Respect of the UCI rules and of UCI World Cup Organisation Guide & Visual Guidelines, on terms and conditions specified in the contract;
- Timing services (company, staff and equipment);
- Promotion of the event;
- Infrastructures for the organisation and the holding of the event;
- VIP area and activities;
- Lodging for UCI representatives (up to 60 nights);
- Anti-Doping related costs;
- · Ground transportation for all UCI Staff;
- Adequate insurance coverage;
- Athlete's identification (bike plates, body numbers, etc.);
- Accreditation services.

9. FINANCE

The provisional budget should be submitted as per the example below together with all necessary additional financial information such as:

- Copies of supporting letter(s) from the public authorities / government / city;
- Any other financial proof that your event will be financially viable.

Budget type (see enclosure 3)

10. GENERAL INFORMATION

■ LOCATION & TRANSPORTATION

A description of approximately 200 words of the location of the event site is required. In addition to this description, a large scale map showing the course location (2 propositions), with details of access to and from main roads, main (and closest) airports, and regional airports should also be included. Travel times to major towns in the area and transportation options are also required. Information about car rental, official airline (if applicable) and any special deals available to participating teams and riders is required.

ACCOMMODATION

Details of the proposed Official Hotel and its distance from the start and finish area are required, together with information about the capacity of accommodation within the area (including the number of wheelchair accessible rooms) as well as the range of prices for a two stars hotel to a four stars hotel.



If the service is available, the contact details of a central accommodation booking system / agency is required.

11. TECHNICAL INFORMATION

■ SCHEDULE

The schedule for the World Cup races is provided by the UCI (see enclosure 4 as an example). If any additional side events apart from the propose schedule are planned, an indication of these should be supplied.

■ COURSE(S)

A description of each of the courses (Road race and Time trial) is required.

These descriptions should also include:

- · Large map of the two possible options;
- · Distance and profile of the both circuit;
- · A diagrammatic plan of the start finish area showing the lap scoring and timing point, catering facilities, car parking areas and team tents;
- · First aid points or/and danger spots;
- Proposed feedzones;
- · Spectator area and access points;
- Description of any particularity.

12. MISCELLANEOUS

Any other information that could be relevant to the bid should also be included.

13. PLANNING & STEPS FOR YOUR CANDIDATURE FILE

July 11st	Deadline for the reception of the bid files.
August	Evaluations, site visits (technical & logistic aspects) if necessary, request for further information, commission decision.
September	Publication of the UCI Para-cycling Road World Cup Calendar after agreement of the UCI Management Committee.
